 - Annual membership fee is set in US dollars according to the total number of campers in 2007 (including winter sessions) regardless of the program used.
 - The Camps in Belarus and Central Asia get the following discounts:

- Camps that own a campsite and rent it out should count the total campers they ran program for (not including campers the lessee ran program for).
- The fee is paid in US dollars or national currency by the current exchange rate.

Full membership privileges are available to a member camp from the day of membership fee payment and submission of this application form, until January 1st, 2009.

CCI/Russia member-camps receive the following benefits:

6. Receive 10% off the retail price of CCI/Russia video and audio resources when purchased from CCI/Russia.
